जांच के दौरान श्रीवास्तव का नाम सामने आया, लेकिन उन्हें गिरफ्तार नहीं किया गया, जबकि सीबीआई के डीएसपी देवेन्द्र कुमार को 2018 में गिरफ्तार किया गया था और बाद में उन्हें जमानत मिल गई। श्रीवास्तव दुबई स्थित कारोबारी और कथित बिचौलिया मनोज प्रसाद का भाई है और इस मामले के मुख्य आरोपियों में एक है। सीबीआई ने मंगलवार को दाखिल किए गए आरोपपत्र में श्रीवास्तव को आरोपी नहीं बनाया है। सीबीआई ने कहा कि कुछ अन्य व्यक्तियों के साथ उनकी भूमिका का पता लगाने के लिए जांच जारी है।

जज ने कहा, 'श्रीवास्तव को गिरफ्तार क्यों नहीं किया गया? मनोज प्रसाद कमजोर कड़ी लगते हैं। श्रीवास्तव आजाद क्यों घूम रहे हैं? नजरे इनायत क्यों? आपने अपने ही डीएसपी को उनके करियर पर ध्यान दिए बिना गिरफ्तार कर लिया।' विशेष सीबीआई न्यायाधीश संजीव अग्रवाल ने कहा, 'इस मामले में बड़ी भूमिका निभाते दिख रहे कुछ आरोपी आजाद क्यों घूम रहे थे जबकि सीबीआई ने अपने ही डीएसपी को गिरफ्तार कर लिया था।' सीबीआई ने कहा कि श्रीवास्तव की भूमिका के संबंध में जांच जारी है।
